3. During the field visit, the evaluation team would also like to meet the Secretary Education/SPD/SCERT Directors for obtaining their views on the same.

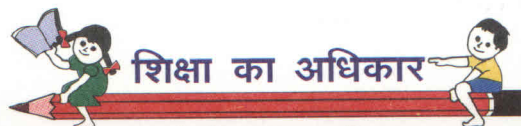
